Request for Cowlitz County Nominations for Board of Directors

Workforce Southwest Washington (WSW) is a Washington State 501(c)(3) nonprofit corporation responsible for the administration and finances of federal Workforce Innovation and Opportunity Act (WIOA) programs operating within Clark, Cowlitz and Wahkiakum counties in Washington State.

WSW contributes to regional economic growth by providing investments and resources to improve the skills and education of the workforce. WSW's goals are to help businesses find and hire the employees they need and provide people the skills, education and training to find work or advance in their careers. WSW partners with businesses, community colleges and universities, labor groups, government and economic development agencies, high schools, and community organizations.

WSW's mission is to prepare and promote a skilled and adaptive workforce for a thriving economy in Southwest Washington.

WSW is seeking nominations to fill two private sector positions representing Cowlitz County on its volunteer board of directors.

Private sector applicants must:

- Be the owner of the business, chief executive or operating officer or other business executive with policymaking or hiring authority.
- Represent a business that provides employment opportunities that include high-quality, work-relevant training and development in local industry sectors such as health care, manufacturing, construction, information technology, transportation and logistics, or other in-demand sectors.
- Either work or live in Cowlitz County.
- Have an interest in workforce development and support WSW's vision that residents have the jobs they want and employers have the workers they need.

Applicants will be required to:

- Attend all board meetings held quarterly in March, June, September and December
- Attend the Board of Directors retreat, occurring biennially in the fall
- Serve on at least one committee (Emerging Workforce [Youth], Community Workforce Partnership, Finance or Executive)
- Be an advocate for the workforce development system by sharing information about workforce programs and services with business and personal connections and facilitate connections between personal contacts and WSW staff, etc.

Applications will be reviewed by a nomination sub-committee of the WSW board and prospective candidates will be interviewed.

Selected individuals will serve a three-year term ending **June 30, 2020**. Individuals may request and be considered by the nomination committee for re-election to the board at the end of their term.

Nominations can be submitted by current WSW members, elected officials, leaders of chambers of commerce, economic development, businesses, labor councils, nonprofit or community-based organizations, professional associations and other organizations.
