Columbia-Willamette Workforce Collaborative Releases Long-Term Care Workforce Plan

VANCOUVER, Wash. (June 11, 2015) – As our population ages, the need for long-term care workers will intensify. To help businesses address the growing need for employees, the Columbia Willamette Workforce Collaborative (CWWC) introduced its "2015-2017 Long-Term Care Workforce Plan" this month.

The plan outlines workforce development goals for the long-term care industry including targeted marketing and messaging to job seekers, developing a vetting process within the workforce system to refer high-quality candidates to businesses, and training opportunities and exposure for youth.

CWWC is comprised of three regional workforce investment boards: Southwest Washington Workforce Development Council (Washington State: Clark, Cowlitz and Wahkiakum counties), Worksystems, Inc. (Oregon: Washington and Multnomah counties and the City of Portland) and the Workforce Investment Council of Clackamas County (Oregon: Clackamas County). CWWC is a partnership that delivers a unified approach to workforce development for the region's major industries, supports economic development and builds a skilled and adaptive workforce to meet the needs of employers in our region.

The region's long-term care sector is anticipated to add more than 6,000 jobs over the next eight years, expanding the current workforce by nearly 25 percent. CWWC has investigated and analyzed data, validating the indispensable and growing role of the long-term care industry in our region and the need for skilled workers in assisted living, nursing homes, adult family homes, home health agencies and other facilities providing medical care and services for children and adults living with chronic health problems.

CWWC continually convenes and meets with regional employers to drive and inform the strategies of the workforce system. The next meeting of long-term care businesses is July 28 in Vancouver.
